Dear friends and distinguished guests,

This year marks a significant milestone as we proudly celebrate the 24<sup>th</sup> anniversary of the Green Council (GC). Over the years, we have navigated many challenges, embraced transformative change, and achieved notable milestones together. This anniversary reflects our progress on the vital journey from sustainability to decarbonisation and reinforces our unwavering commitment to collaboration with our network members and stakeholders as we eagerly anticipate our 25<sup>th</sup> anniversary next year.

As a United Nations (UN) accredited NGO, we actively engaged in global forums and meetings to tackle pressing issues such as climate change, carbon emissions, water and waste management, plastic pollution, sustainable construction and procurement, resources efficiency, and the circular economy. This engagement allows us to integrate these critical topics into our initiatives, empowering our members to enhance their sustainability performance.

Since the inception of the Hong Kong Green Awards (HKGA) in 2010, which initially featured just two categories, we have significantly broadened our scope. We now include the Corporate Green Governance Award (CGGA), recognising the sustainability efforts of large corporations, and have refined the Green Management Awards (GMA) into three distinct categories: Project Management, Service Provider, and Corporate Management. Furthermore, we have introduced the Environmental, Health, and Safety Award (EHSA) and the Sustainable Procurement Award (SPA), both of which underscore the importance of embedding sustainable and environmental considerations into business operations and standards.

Our commitment to supporting our members extends to providing opportunities for them to monitor their environmental management performance and sustainability development while actively advocating for the United Nations Sustainable Development Goals (UNSDGs) in Hong Kong through collaborative initiatives.

Our first inaugural annual event organised in 2002, aims to enhance public awareness, knowledge, and responsibility regarding environmental issues. Additionally, we host the "Ecomodel Tournament," which promotes environmental protection through interactive activities that encourage primary and secondary school students to creatively utilise recyclable materials in their designs. Events such as the "Green Day" will take place throughout June, targeting public, corporate, and academic sectors. We remain steadfast in our mission to encourage the community to adopt sustainable living practices, ultimately contributing to the transformation of Hong Kong into a more sustainable city.

Among our highlighted initiatives this year is organising "Reward • Regift - Corporate ESG Programme" (綠續回贈), which has successfully educated employees from participating corporations on effective recycling practices and the importance of waste separation. This initiative fosters corporate social responsibility and supports sustainable development in Hong Kong. The recyclables collected are directed to the GREEN@COMMUNITY facilities, where participants can earn redeemable points for rice, which is then distributed to assist underprivileged families in partnership with our corporate members.

To further bolster our corporate members, we have launched the "SDG Actions Hong Kong" platform, which provides comprehensive training and seminars on the 17 Sustainable Development Goals (SDGs). This platform also coordinates services and training related to ISO Management, the Hong Kong Green Label Scheme, the Sustainable Procurement Charter, and ESG and Sustainability Assessment. Looking ahead, we are excited to integrate relevant international ESG standards and artificial intelligence (AI) into our programmes and assessments, enhancing our overall impact.

With the progress and positive momentum, we have achieved this year, I am confident that we can further enrich and expand our work programme. While our current initiatives will continue to evolve, we also plan to introduce unique and complementary initiatives designed to support our network members and stakeholders in their ESG transition.

In closing, I would like to extend my heartfelt appreciation to the Executive Committee Members for their invaluable guidance and support, as well as to my dedicated team. Congratulations to all awardees! Your significant contributions are deeply appreciated. I look forward to your continued efforts and even greater achievements in the future.





### ABOUT GREEN COUNCIL



The Green Council is a non-profit, non-partisan, tax-exempt charitable (Ref. No.: 91/6063) environmental stewardship organisation and certification body (Reg. No.: HKCAS-027) of Hong Kong established in 2000. A group of individuals from different sectors of industry and academics shared the vision to help build Hong Kong into a world-class green city for the future. They formed the Green Council with the aim of encouraging the industrial and commercial sectors to include environmental protection in their management and production processes.

With the motto of "Conservation begins with Education", the Green Council is fully committed to provide continued education and training on sustainable procurement, environmental management, waste management, energy conservation, etc. The main sources of funding are from membership fees, public donations and sponsorships by corporations and individuals who share our vision. Where appropriate, we apply for funding from government sources for specific projects.



#### **GREEN COUNCIL HIGHLIGHT OF INITIATIVES**

#### **SDG Actions Hong Kong**

On June 28, 2024, the United Nations Department of Economic and Social Affairs released the latest Sustainable Development Report, revealing that global progress towards the 2030 Agenda is significantly off track. Notably, 18% of the goals have stagnated, and 17% are performing worse than the 2015 baseline.

In response, the Green Council launched SDG Actions Hong Kong to promote sustainable development in the region. This programme aims to unite businesses, academia, and individuals to inspire and facilitate meaningful actions for a sustainable future under the mission "Together Towards Tomorrow."

In its first phase, registrants will benefit from updates on sustainable development goals (SDGs) and have their names featured on an online list, demonstrating their commitment. They may also use the "SDG Actions Hong Kong" logo on printed or digital materials, excluding commercial use.





#### Reward • Regift - Corporate ESG Programme

Since 2013, the Green Council has designated June 5 as "Hong Kong Green Day" in alignment with the United Nations World Environment Day, encouraging residents to "go green, act green." This annual event promotes a sustainable lifestyle and culture, extending into a "Green Month" filled with activities for businesses, community organizations, schools, and the public.

In 2024, "Hong Kong Green Day" features the inaugural program "Reward • Regift - Corporate ESG Programme", which aims to harness business collaboration for greater social impact, promoting waste reduction and recycling. Participating employees can submit clean, sorted recyclables at GREEN@COMMUNITY facilities and earn rewards through their business's exclusive "GREEN\$" account, redeemable for rice to support those in need.

We also coordinate volunteer services for organisations to distribute redeemed rice to underprivileged communities through the Government's Community Living Room Project. This initiative encourages employees to practice clean recycling and engage in volunteer activities, enhancing corporate social responsibility and supporting sustainable development in Hong Kong. The Green Council plans to expand this initiative next year for even greater impact. We invite businesses to join us in making a difference!







#### Certification

Our professional certification services enable you to demonstrate that your products, processes or systems are compliant with local and international regulations and standards.





#### Hong Kong Green Label Scheme

In the past 24 years, the Green Council has navigated numerous challenges alongside our members and partners through our initiatives to cater a wide range of industries. One of our significant initiatives is the first labelling scheme 'Hong Kong Green Label Scheme (HKGLS)', launched in 2000 as a voluntary certification for environmentally preferable products.

It awards a "Green Label" to products that meet specific environmental criteria. encouraging sustainable consumption and helping consumers identify eco-friendly options.



#### **Recycled Content Certification**

"Hong Kong Green Label Scheme - Recycled Content Certification (RCC)" is an independent and voluntary scheme to evaluate products made from pre-consumer and post-consumer materials diverted from the waste stream. RCC verifies and certifies the percentage of recycled content to make an accurate claim under the ISO 14021 Type II (self-declared environmental claims) label.



ESG is now widely accepted as a vital duty for leading organizations. Of these three aspects, Environment and Social aspects are easily recognized and measured, and good standards are expected. However, the Governance aspect is equally important but much more difficult to quantify. This Green Award aims to assess the Governance quality of organizations to ensure they are of high importance.

Good governance ensures a high level of transparency of the policies and directions of an organization and enables an effective check and balance of the various activities of their business. It also allows early warning in the event of crisis and facilitates early corrective actions for healthy operation.

Year on year, I note that our contestants have submitted projects of extremely high quality and have shown good attention to all three components of ESG. This confirms their understanding of these vital pillars supporting the solid foundation of successful organizations.







#### 二、嚴控"三廢"排放, 實現更高效的能源資源利用

#### 1.嚴格控制,火電專案100%超低排放

華潤電力因地制宜選擇超低排放改造技術路線,連續多 年加大改造投入資金,加速超低排放改造,於2020年全 部實現超低排放。此外,滄州、豐潤、渤海新區、曹妃 甸等專案實施煙氣深度治理,顆粒物、二氧化硫、氮氧 化物排放濃度分別達到5mg/Nm³、25mg/Nm³、30mg/ Nm³以下,為區域空氣品質提升做出突出貢獻。











#### 2.綜合治理,最大限度減少水資源消耗

華潤電力持續開展廢水綜合治理,加強水的梯級利用, 提高廢水重複利用效率,積極擴大使用城市中水,旗下磴 口、盤錦、豐潤等11家火力發電廠使用城市中水替代新鮮 用水,受封項目重複利用上游煤礦企業的礦井水替代新鮮 用水,最大限度減少水資源消耗。
